VALUE STRATEGY AND SUSTAINABILITY

Our giving partners appreciate strategic, sustainable ministry. Training leaders creates a ripple effect. On average, over the past two decades, for every pastor or Bible teacher equipped, 122 congregants have been

reached. We trust that the Holy Spirit is working in the lives of congregants across the country and around the world as they sit under more faithful and clear preaching and Bible teaching.

Training leaders is a sustainable way to support the global mission of the church. About half the pastors and Bible teachers we serve each year are outside the US and Canada—some in difficult to access nations. And we go beyond equipping pastors for their local ministries by training some pastors to become instructors at Workshops and in Online Courses. In addition to lowering costs and being sustainable, this empowers local leaders and broadens their ministry platforms.

REMEMBER US IN YOUR ESTATE PLANNING

The idea of helping a Christian organization with a gift that could make a significant difference appealed to David and Straw Hidaka. Their philanthropic story begins with David's faith story. David did not come from a church background, but at age 40 he was given a pocket New Testament by a coworker. Convicted by Scripture, he came to saving faith in Jesus Christ. So David knows first-hand the power of God's Word in salvation. From then, he hit the ground running and never looked back. Studying God's Word seriously is his passion—and he has shared that passion by teaching adult Sunday school for 26 years at Country Acres Baptist Church in Wichita, Kansas. At the same time, Straw ran a longstanding evangelistic street ministry for vulnerable women and their children.

David and Straw believe that many churches neglect to "preach the Word . . . in season and out of season" (2 Timothy 4:2). And so, they have come to appreciate sound biblical preachers. They recognize the urgent need for more in quantity and, especially, quality. When they

asked their pastor, Dr. Kelly Randolph, how they could use their resources to promote faithful preaching, they received an important answer: the Charles Simeon Trust.

Generosity is important to them. "I was a stockbroker for many years," said David. "My mentor, who was also a client, taught me a valuable lesson. Vic would donate stocks to various Christian organizations. Even though Vic was not a really wealthy person, his donations were sometimes in the six-figure range. I was somewhat set back over his generosity. But God increased Vic's stock account again and again, all so he could give away more. He taught me 2 Corinthians 9 without speaking a word," David continued. "Vic went to heaven at age 94. God presented me the best in a mentor. Vic always had the faith that I wish I had."
